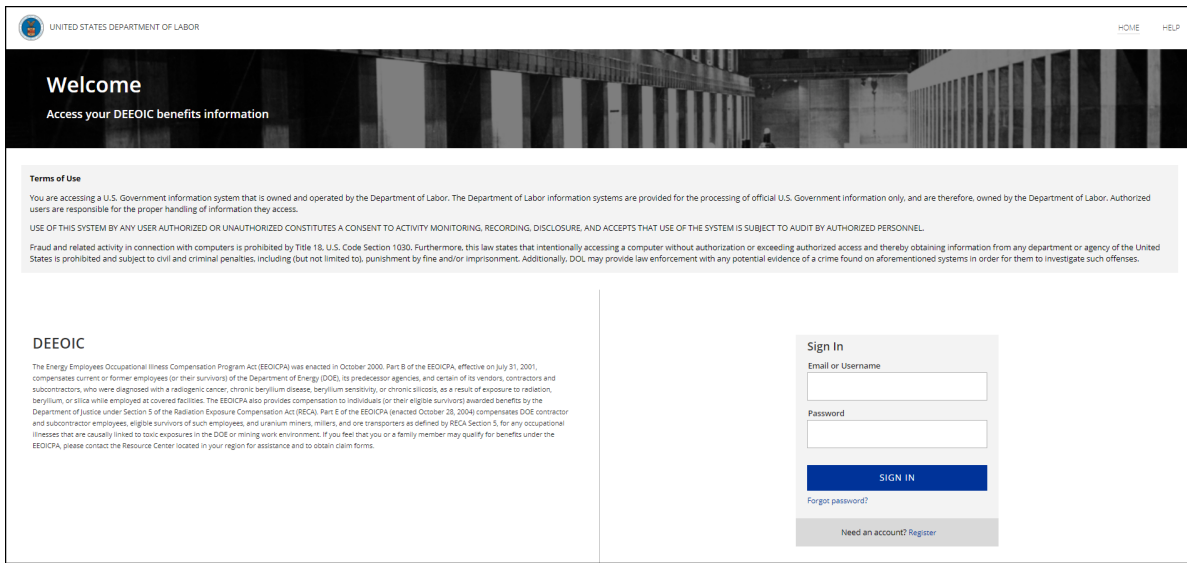




Employees' Compensation Operations & Management Portal (ECOMP): Claimant Imaging

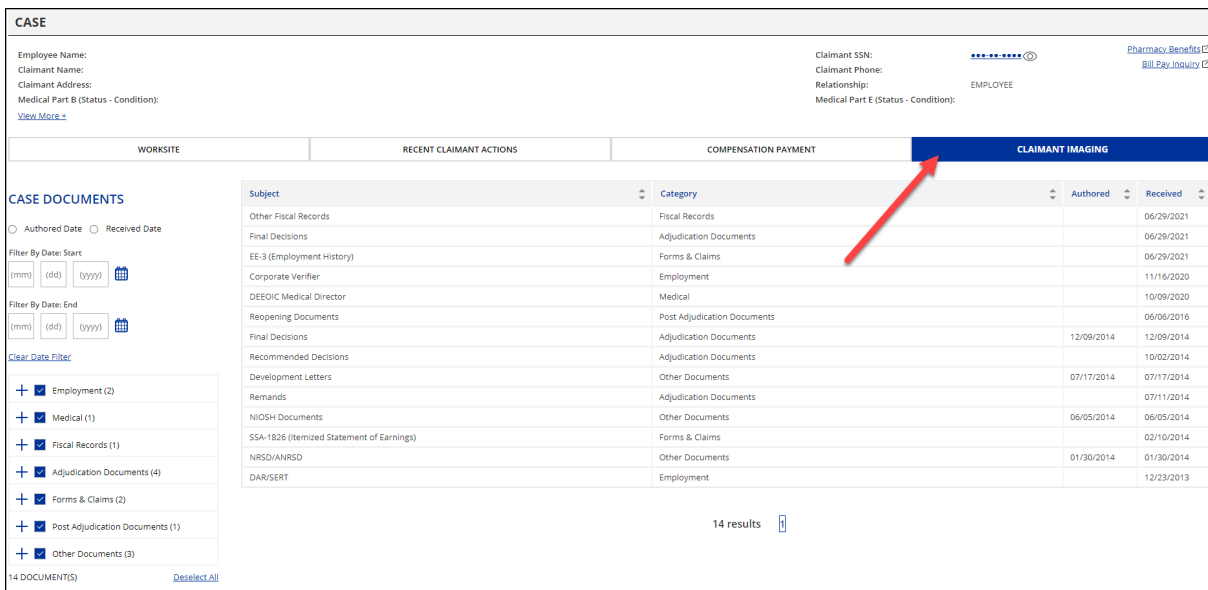
This job aid will provide instruction for employee claimants on reviewing and downloading case specific documents from the Employees' Compensation Operations & Management Portal.

1. Sign-in to ECOMP.

2. The Claimant Imaging tab is new and will provide you access to case specific documentation.

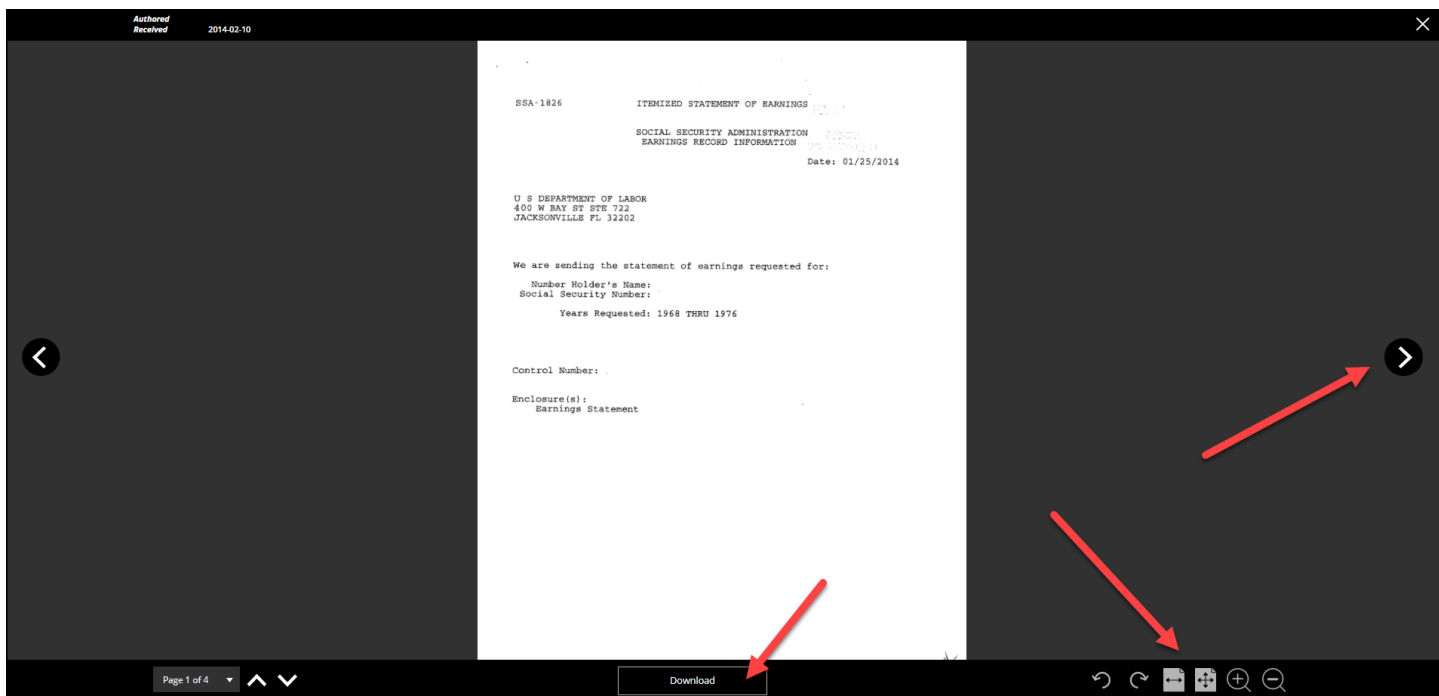
